**Instructions.** Please read carefully. Fill in all blanks and attach additional paperwork as needed. This form is for the application of general abatements only. General abatements are for pool fill-ups, meter errors, leaks, or miscellaneous billing issues. Any petition for abatement must be filed in writing to the Town of Norridgewock within 30 days of the date reflected in the "billing date" section of the usage bill. The filing of this form does not guarantee that your abatement will be granted. The filing of this form does not relieve the applicant of the responsibility to pay the sewer usage bill in full by the due date specified. Abatements will be considered by the Town of Norridgewock Sewer Commission on a case-by-case basis. Approved abatements will be reflected as an account credit in the next billing period. 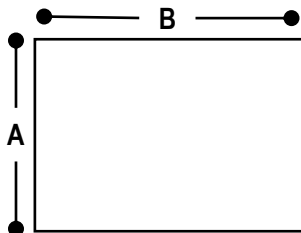

<b>Leak or Meter Abatement</b> For abatements of water volumes caused by leaks that were not discharged into the sewer. This includes leaks on outdoor water pipes or on pipes before plumbing fixtures (sinks, toilets, etc.). This does not include leaking toilet valves or faucets. <i>Attach documentation from the Water District, plumber, etc.</i>	<b>Date of Leak</b>
<b>Pool Abatement</b> For abatements of one-time pool fill-ups. This adjustment is for permanently installed in-ground or above-ground pools only. This excludes temporary pools or seasonal refilling/topping off. <i>Attach photo of pool, provide pool dimensions in Part C. Attach copies of receipts for new pool, pool liner replacement, or leak service.</i>	<b>Date of Pool Fill-up</b>
<b>Miscellaneous One-Time Adjustment</b> For all other one-time abatements and billing adjustments. These will be considered on a case-by-case basis and any adjustment granted will be based on the circumstances described by the customer and by review of historical usage data. <i>Attach documentation/narrative describing the abatement request and justification, including any calculations in Part D.</i>	<b>Date of Abatement Event</b>

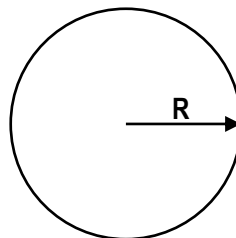
