1. Call to Order, Introductions

Mr. LaBelle called the meeting to order at 5:00 PM.

3. Election of Officers

Nominations for Chair were opened. Mr. Malek nominated Joe Clark. Mr. Clark nominated John Malek; Mr. Malek declined. Ms. Wilder nominated Becky Ketchum. There being no further nominations, nominations ceased. Joe Clark is ELECTED CHAIR by a vote of 4-2.

Nominations for Vice Chair were opened. Ms. Anderson nominated Becky Ketchum. There being no further nominations, nominations ceased. Becky Ketchum is ELECTED VICE CHAIR.

Nominations for Secretary were opened; there were no nominations. The Town Manager will serve in the Secretary's capacity without committee objection.

4. Discussion/Action on January 21, 2025 Minutes

Ms. Ketchum made a MOTION to approve the January 21, 2025 meeting minutes. Seconded by Mr. Malek. MOTION PASSED.

5. Review of Elected Officials' Stipends

Mr. Malek made a MOTION to recommend shifting \$600 from the Tax Assessor stipend to the Select Board. There being no second, the MOTION FAILED.

Mr. Clark made a MOTION to recommend \$10,000 for Select Board, \$2,000 for Tax Assessor, and \$3,000 for Planning Board. There being no second, the MOTION FAILED.

Ms. Ketchum made a MOTION to recommend \$10,000 for the Select Board, \$1,500 for Tax Assessor, and \$2,500 for Planning Board. Seconded by Ms. Anderson. MOTION

6. Review Proposed 2026 Budget

Ms. Ketchum made a MOTION to recommend the Town Manager's recommendation for Fire in the amount of \$354,100.00 Seconded by Ms. Anderson. MOTION PASSED, 7-0 (Clark, Ketchum, Anderson, Desroches, Malek, Obert, Wilder in favor; none opposed).

Mr. Clark made a MOTION to recommend the Town Manager's recommendation for Parks in the amount of \$40,950.00 Seconded by Mr. Malek. MOTION FAILED, 5-2 (Clark, Malek in favor; Ketchum, Anderson, Desroches, Obert, Wilder opposed).

Mr. Malek made a MOTION to recommend Parks in the amount of \$33,240.00 Seconded by Ms. Anderson. MOTION PASSED, 5-2 (Clark, Ketchum, Anderson, Malek, Wilder in favor; Desroches, Obert opposed).

Ms. Anderson made a MOTION to recommend the Town Manager's recommendation for Libraries in the amount of \$54,335.00 Seconded by Ms. Ketchum. MOTION PASSED, 7-0 (Clark, Ketchum, Anderson, Desroches, Malek, Obert, Wilder in favor; none opposed).

Mr. Malek made a MOTION to recommend the Town Manager's recommendation for Code Enforcement in the amount of \$52,065.00 Seconded by Ms. Anderson. MOTION PASSED, 6-1 (Clark, Ketchum, Anderson, Desroches, Malek, Wilder in favor; Obert opposed).

Ms. Ketchum made a MOTION to recommend the Town Manager's recommendation for Planning Board in the amount of \$4,200.00 Seconded by Mr. Malek. MOTION PASSED, 7-0 (Clark, Ketchum, Anderson, Desroches, Malek, Obert, Wilder in favor; none opposed).

Mr. Malek made a MOTION to recommend the Town Manager's recommendation for Local Philanthropy in the amount of \$8,000.00 Seconded by Ms. Anderson. MOTION PASSED, 7-0 (Clark, Ketchum, Anderson, Desroches, Malek, Obert, Wilder in favor; none opposed).

Ms. Desroches made a MOTION to recommend the Town Manager's recommendation for Summer Grounds in the amount of \$45,000.00 Seconded by Ms. Anderson. MOTION PASSED, 7-0 (Clark, Ketchum, Anderson, Desroches, Malek, Obert, Wilder in favor; none opposed).

Ms. Anderson made a MOTION to recommend the Town Manager's recommendation for Debt Service in the amount of \$96,115.00 Seconded by Ms. Ketchum. MOTION PASSED, 7-0 (Clark, Ketchum, Anderson, Desroches, Malek, Obert, Wilder in favor; none opposed).

Ms. Desroches made a MOTION to recommend the Town Manager's recommendation for Unclassified in the amount of \$32,002.00 Seconded by Ms. Ketchum. MOTION PASSED, 7-0 (Clark, Ketchum, Anderson, Desroches, Malek, Obert, Wilder in favor; none opposed).

Mr. Malek made a MOTION to recommend the Town Manager's recommendation for Contingency in the amount of \$4,200.00 Seconded by Ms. Ketchum. MOTION PASSED, 7-0 (Clark, Ketchum, Anderson, Desroches, Malek, Obert, Wilder in favor; none opposed).

Mr. Malek made a MOTION to recommend the Town Manager's recommendation for Administration in the amount of \$503,550.00 Seconded by Ms. Anderson. MOTION PASSED, 6-1 (Clark, Ketchum, Anderson, Desroches, Malek, Wilder in favor; Obert opposed).

Mr. Malek made a MOTION to recommend Elected Officials in the amount of \$21,125.00 Seconded by Ms. Anderson. MOTION PASSED, 6-1 (Clark, Ketchum, Anderson, Desroches, Malek, Wilder in favor; Obert opposed).

Ms. Ketchum made a MOTION to recommend the Town Manager's recommendation for Tax Assessing in the amount of \$28,000.00 Seconded by Ms. Desroches. MOTION PASSED, 7-0 (Clark, Ketchum, Anderson, Desroches, Malek, Obert, Wilder in favor; none opposed).

Ms. Desroches made a MOTION to recommend the Town Manager's recommendation for Public Safety in the amount of \$136,595.00 Seconded by Mr. Malek. MOTION PASSED, 7-0 (Clark, Ketchum, Anderson, Desroches, Malek, Obert, Wilder in favor; none opposed).

Ms. Desroches made a MOTION to recommend the Town Manager's recommendation for Public Works in the amount of \$775,525.00 Seconded by Mr. Malek. MOTION PASSED, 7-0 (Clark, Ketchum, Anderson, Desroches, Malek, Obert, Wilder in favor; none opposed).

Mr. Malek made a MOTION to recommend the Town Manager's recommendation for Cemeteries in the amount of \$8,400.00 Seconded by Ms. Anderson. MOTION PASSED, 7-0 (Clark, Ketchum, Anderson, Desroches, Malek, Obert, Wilder in favor; none opposed).

Ms. Anderson made a MOTION to recommend the Town Manager's recommendation for General Assistance in the amount of \$5,600.00 Seconded by Ms. Desroches. MOTION PASSED, 7-0 (Clark, Ketchum, Anderson, Desroches, Malek, Obert, Wilder in favor; none opposed).

Mr. Clark made a MOTION to recommend the Town Manager's recommendation for Recreation in the amount of \$54,140.00 Seconded by Mr. Malek. MOTION PASSED, 4-3 (Clark, Anderson, Malek, Obert in favor; Ketchum, Desroches, Wilder opposed).

Mr. Malek made a MOTION to recommend the Capital Reserves budget as proposed by the Town Manager, less \$20,000 for Recreation and \$10,000 for Cemeteries. Seconded by Ms. Wilder. Ms. Ketchum made Ms. Wilder aware of the proposed reduction to the Cemetery Reserve; Ms. Wilder withdrew her second. There being no second, the MOTION FAILED.

Mr. Clark made a MOTION to recommend the Capital Reserves budget as proposed by the Town Manager, less \$10,000 for Parks, \$25,000 for Public Works Equipment, \$10,000 for Public Works Building, and \$250,000 for Roads, resulting in a total of \$900,000.00. Seconded by Mr. Obert. MOTION FAILED, 5-2 (Clark, Obert in favor; Ketchum, Anderson, Desroches, Malek, Wilder opposed).

Ms. Desroches made a MOTION to recommend the Capital Reserves budget as proposed by the Town Manager, less \$10,000 for Parks, \$25,000 for Public Works Equipment, \$10,000 for Public Works Building, and \$100,000 for Roads, resulting in a total of \$1,050,000.00. Seconded by Mr. Malek. MOTION PASSED, 5-2 (Clark, Desroches, Malek, Obert, Wilder in favor; Ketchum, Anderson opposed).

Mr. Clark made a MOTION to recommend Anticipated Local Revenues as proposed by the Town Manager in the amount of \$2,064,947.00. Seconded by Ms. Anderson. MOTION PASSED, 6-1 (Clark, Ketchum, Anderson, Desroches, Malek, Wilder in favor; Obert opposed).
